Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and safeguard any information when you visit our website.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at <https://whaleden.com/>. The terms "we," "us," and "our" refer to the Company. "You" refers to you, as a visitor of our Site.

By accessing our Site, you accept our Privacy Policy and you consent to our collection and use of information as described in this Privacy Policy.

I. INFORMATION WE COLLECT

We collect two types of information: "Non-Personal Information" and "Personal Information." Non-Personal Information includes information that cannot be used to personally identify you. Personal Information includes any information that can be used to identify you personally.

Information collected via Technology

Our website is primarily informational and does not require you to submit any personal information to browse and view content. However, like most websites, we automatically collect certain non-personal information to improve the quality of our Site. This may include information provided by your browser when you visit the Site, such as:

- The website you came from (known as the "referring URL")
- The type of browser you use
- The device from which you connected to the Site
- The time and date of access
- Pages viewed on our Site
- Your approximate geographic location (based on IP address)

We track this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to your browser from our servers and are stored on your computer. This enables us to collect non-personal information and improve your browsing experience.

The Company may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser.

Information you provide us through forms

Our website includes optional contact or inquiry forms. If you choose to fill out these forms, you may provide us with personal information such as:

- Your name
- Email address
- Phone number (if requested)
- Message or inquiry details
- Any other information you choose to include

Submitting information through our forms is entirely optional. You can view and use our website without providing any personal information.

Children's Privacy

The Site is not directed to anyone under the age of 13. The Site does not knowingly collect or solicit information from anyone under the age of 13. If you believe we have collected such information, please contact us at privacy@whaleden.com.

II. HOW WE USE AND SHARE INFORMATION

Personal Information

If you choose to submit personal information through our contact forms, we use this information solely to respond to your inquiry or request. We do not sell, trade, rent or otherwise share your personal information with third parties for marketing purposes without your consent.

We may share personal information with vendors who are performing services for the Company, such as email service providers who help us respond to your inquiries. Those vendors use your personal information only at our direction and in accordance with this Privacy Policy.

We may share personal information with outside parties if we have a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to meet any applicable legal process or enforceable governmental request; to address fraud, security or technical concerns; or to protect against harm to the rights, property, or safety of our users or the public as required or permitted by law.

Non-Personal Information

We use non-personal information collected through website analytics to:

- Improve the Site and customize the user experience
- Track general trends and analyze use patterns on the Site
- Ensure the Site functions properly across different browsers and devices

This Privacy Policy does not limit in any way our use or disclosure of non-personal information and we reserve the right to use and disclose such non-personal information to our partners, advertisers and other third parties at our discretion.

In the event we undergo a business transaction such as a merger, acquisition by another company, or sale of all or a portion of our assets, any information we have collected may be among the assets transferred. You acknowledge and consent that such transfers may occur and are permitted by this Privacy Policy.

III. HOW WE PROTECT INFORMATION

We implement security measures designed to protect any information from unauthorized access. We protect information from potential security breaches by implementing certain technological security measures including encryption, firewalls and secure socket layer technology. However, these measures do not guarantee absolute security. By using our Site, you acknowledge that you understand and agree to assume these risks.
